### 2.01 FEATURES

- A. The Digital Watchdog High Quality Digital Color Camera shall be equipped with a 1/3" Sony Super II HAD CCD.
- B. The High Quality Digital Color Camera shall produce 540 TV Lines in the horizontal direction for color images and 570 TV Lines for black-and-white images.
- C. The High Quality Digital Color Camera shall have an auto iris vari-focal lens. The lens shall offer a focal length that varies from 3.3 to 12 millimeters. The lens shall detect the amount of light entering the lens and automatically open/close the iris to maintain appropriate exposure.
- D. During the day, the High Quality Digital Color Camera shall operate as a color camera, and the camera shall be capable of switching to black-and-white in low light conditions. At low light conditions, the High Quality Digital Color Camera shall use ambient IR light to capture black-and-white images.
- E. The High Quality Digital Color Camera shall be built with a BLC (Backlight Compensation) technology that automatically gives the camera the necessary light level compensation and provides a good image of the subject in the foreground when there is a bright source in the background. BLC is usually good when there is a subject of interest, like an ATM machine.
- F. The High Quality Digital Color Camera shall include an ICON-driven OSD (On-Screen Display) menu with a built-in joystick that will make programming quicker and easier.
- G. The High Quality Digital Color Camera shall be configurable for several foreign languages, other than English. The High Quality Digital Color Camera shall include the following foreign languages: Korean and Chinese.
- H. The Value Line Bullet Camera shall have a Wide Operating Voltage of 8 Volts to 18 Volts DC.
- I. The High Quality Digital Color Camera shall also include a secondary video-BNC output with a cable for easy installation.
